## Entry Information and Guidelines

**ELIGIBILITY:** Open to all artists 18 or older. Artwork (both 2D and 3D) must be original—not produced with the assistance of an instructor, and completed within the last 3 years. In addition, it should not have been exhibited in any prior WVAG Spring Art Show.

**ENTRY FEE:** The non-refundable fee of \$20 (members) and \$30 (non-members) covers the submission of three works per artist. Applicants may mail their entry fee to **WVAG, PO Box 3958, Terre Haute, IN 47803**, but mailed forms must be post-marked by **MONDAY, APRIL 23rd**.

**DELIVERY & RETURN OF ARTWORK:** All artwork must be hand-delivered on Thursday, May 6th between 4PM and 7PM EST, wired for hanging, and appropriate for presentation. Questionable imagery will be omitted from the show. **No entries will be accepted on Friday.** Please check in with Exhibit Committee before setting up.

Participants will be responsible for removal of their artwork and equipment from the shopping center following the show on Sunday May 9th between 4 PM and 5 PM EST. No artwork is to be removed before 4 PM EST.

**LIABILITY:** Although every precaution will be taken to safeguard artwork, WVAG nor Honey Creek Mall will be responsible for injuries to participants or the loss or damage to artwork during the show.

**SALES:** As artists are encouraged but not required to sell their work, no commissions will be retained by WVAG. Each individual artist is responsible for negotiating the sale with potential customers. If a piece is sold, the Buyer may take the artwork with them unless it is a prize-winning piece or if it is before judging has been completed. The artist may replace the sold piece with another. Boxes and packaging materials are to be removed from sight both during and after the show's end.
