

Sales: All artists are encouraged to sell their art work, no commission will be retained by the WVAG. Each individual artist is responsible for negotiation the sale with potential customers. If a piece is sold the buyer may take the piece at the end of the exhibition on May 1st. Boxes and packaging must be removed from site prior to judging, during and after the show.

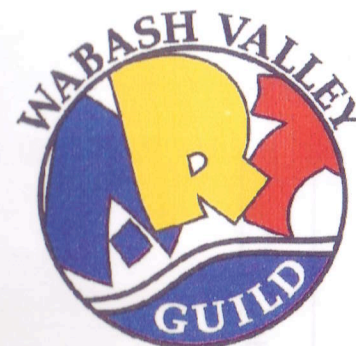
Eligibility: This exhibition is open to all artists 18 years old or older. Artwork must be original- not produced with assistance of an instructor, and completed within the last three years. The work cannot have been shown in any previous WVAG Spring Art Show.

Entry Fee: A non-refundable fee of \$20.00 (members) or \$30.00 (non-members) for three pieces of artwork is due at the time the application is submitted. Applicants should mail their fee and application By April 20th to **WVAG, c/o Jane Dusanic, 5726 E. Cougar Dr., Terre Haute, Indiana 47802**

Delivery of art work: Art work must be hand delivered on Thursday, April 28th between 4 -6 PM, wired for hanging and appropriate for presentation. Questionable imagery will be omitted from the show. No entries will be accepted on Friday, April 29th.

Pick up will be Sunday, May 1st at 4:00PM. No work is to be removed before 4:00 PM.

Liability: Although every precaution will be taken to safeguard work, neither WVAG nor Honey Creek Mall will be responsible for injuries to participants or the loss or damage to artwork during the show.
